R/O met with [redacted] at his residence on March 18' 2002 at 1100 hrs. R/O interviewed him about his involvement with Jim Mulcahy. [redacted] stated that he had been in contact with [redacted] and knew that someone from the Sheriff's Office would be stopping to see him. [redacted] did relate that when he was around 13 years old Jim Mulcahy was his Religious Ed instructor from St Pat's church in Mt Morris. [redacted] stated that Jim would have informal retreats at his house on Chidsey Rd in Nunda on the weekends and that kids would go up their and stay the weekend. [redacted] further related that on at least two or three occasions while he was there Jim did sodomize him. [redacted] stated that Jim told him not to say anything about it as he would get into trouble at his job which was an English teacher at MMCS. A detailed deposition was obtained from [redacted] and attached to this report.

R/O spoke with Mark Valentino who is the H.S. Principal at MMCS. Mark related that since he took over as Principal eight years ago Mulcahy had not been employed there. He did some checking and found out that Mulcahy did teach English there from 1979 through August of 1981 when he resigned. Mark stated that there is no reason given for the resignation.

R/O spoke with Steve Rapp about the possibility of Livingston County DSS placing youths at Mulcahy's for a foster home. R/O also asked him to look specifically into [redacted] as he is the original complainant. Rapp told R/O that Mulcahy is not listed with DSS as a foster parent and could find no information on [redacted] being placed there through DSS. Rapp further related that he knows of Mulcahy personally and that he believes that he is employed at Park Ridge Hospital as a Chaplain. Rapp stated that he has heard rumors that Mulcahy is homosexual but has no first hand knowledge. He stated that Mulocahy is a little different and that he would not be suprised if he was a pedaphile.

R/O went to Mulcahy's neighborhood to check with neighbor's to see if there are any young children staying with Mulcahy now. The closest house near Mulcahy's is approx. 1/2 mile away and there was nop one home. I did locate a 2000 blue Dodge car bearing [redacted] in Mulcahy's driveway. The reg returns to [redacted]. Further checking produced a street address fo. [redacted] which is Mulcahy's residence. (9781 Chidsey Rd).

Wednesday 03-20-02

R/O attempted to contact Tim McMann of Catholic charities to see if he has any information on Mulcahy. A message was left for him to contact R/O. Inv Ellis related that he had spoken with McMann about Mulcahy when the first complaint came in in 1994 and was told that he did not know him. R/O also attempted to contact Fr Brown of St Pat's church in Mt Morris. He was out of town for the day and a meeting was set up for tomorrow at 1115 hrs.

R/I was assigned to interview Compl. [redacted] with [redacted] regards to possible sex offenses that occurred 15- 20 years ago, but involve a James Mulcahy. R/I spoke wit [redacted] in the LCJ. [redacted] relates that while he was a foster kid in Mulcahy's home in Nunda that for a period of two years, James Mulcahy sodomized him about once a week for the two year period. He states that Mulcahy would come into his room about once a week and suck on his peni. [redacted] states that he never told anyone until recently. He states that he has struggled with this for some time. He states that he has dealt with it in his own way. He states that he saw some news articles about priests molesting kids and it brought the issue back to the forefront of his mind. [redacted] states he is aware that nothing can be done criminally in his case, but wishes an investigation as he believes that Mulcahy still takes in foster kids and he doesn't want anymore kids screwed up by this. [redacted] states that he has talked with [redacted] of Mt. Morris who was also a kid that stayed in Mulcahy's house and [redacted] told him that Mulcahy did the same to him. [redacted] believes there are many other "victims" because a lot of kids were placed in Mulcahy's home. R/I took a deposition from [redacted] and advised him that I would keep him apprised of the investigation. R/I checked in house and found a prior sex abuse/ sodomy compl. from 1994 with Mulcahy as the suspect and another adult complainar. [redacted] Unknown where that case went as the report stops after some attempts at making control calls to suspect. [redacted] R/I to try and locate [redacted] and interview him.
